SUBJECT: Off Limits Establishments

1. Under the provision of AFI 31-213, *Armed Forces Disciplinary Control Boards and Off-Installation Liaison and Operations*, dated 5 July 2018, substantive information has been received indicating that the below establishments and areas adversely affect the health, safety, welfare, and morale of Armed Forces personnel.

2. The below establishments are declared "off-limits" until issuance of an updated notice. Off-limits means that military personnel are prohibited from conducting business with and entering the premises of the off-limits establishments shown below.

a. Black Dragon Smoke Shop, 3627 East Ash Street, Goldsboro, NC 27534

3. Violations are punishable under Article 92 of the Uniform Code of Military Justice. This memorandum will be posted on the Seymour Johnson AFB website. Off-limits establishments for other nearby bases are included in the attachment to this memo and are also available at <https://www.seymourjohnson.af.mil/About-Us/Fact-Sheets/Display/Article/1438881/off-limits-establishments/>. All military personnel assigned to or performing duties at Seymour Johnson AFB are prohibited from entering all off-limits establishments in this and other military installations' notices.

SUBJECT: Off-Limits Establishments

1. Reference. Army Regulation 190-24/OPNAVINST 1620.2A/AFI 31-213/MCO 1620.2D/COMDTINST 1620.1E; Armed Forces Disciplinary Control Boards and Off Installation Military Enforcement Service, 27 July 2006.

2. The following commercial and recreational properties are off-limits to members of the Armed Forces:

a. **McCormick Farm Property**, Highway 210 on McCormick Bridge Road, Spring Lake, NC 28390. This off-limits designation pertains only to the area above and underneath the Lower Little River Bridge. Upon the landowner's authorization, all other McCormick Farm property is available for patronage.

b. **All unlicensed tattoo parlors. Off-limits: Pre 2007**; Concerns: Poor business practices and community welfare.

c. **365 Fast Mart**, 5001 Bragg Boulevard, Fayetteville, NC 28303. **Off-limits: 09 June 2008**; Concerns: High crime, illegal drugs, prostitution, black marketing, and gang activity.

d. **Peaches Adult Boutique and Arcade**, 115-B Swain Street, Fayetteville, NC 28301. **Off-limits: Pre 2007**; Concerns: Prostitution.

e. **The Vault**, 2527 Gillespie Street, Fayetteville, NC 28306. **Off-limits: Pre 2007**; Concerns: High crime, alcohol beverage control violations, and gang activity.

f. **Supreme Smoke**, 4935 Bragg Boulevard, Fayetteville, NC 28303. **Off-limits: Pre 2007**; Concerns: Illegal drugs and drug paraphernalia.

g. **Promoted Party Events hosted by:**

(1) Host: Mr. Raheem Davis, a.k.a. DJ Teddi Petti; **Off-limits: 15 February 2022**; Concerns: High crime, illegal drugs, and alcohol beverage control violations.

(2) Host: Mr. Donovan McGeachy, a.k.a. DJ Don Don; **Off-limits: 26 May 2022**; Concerns: High crime, illegal drugs, and alcohol beverage control violations.

SUBJECT: Off-Limits Establishments

h. **Airborne Hookah Lounge**, 5007 Raeford Road, Fayetteville, NC 28304, **Off-limits: 26 May 2022**; Concerns, illegal drugs.

i. **Sparky's Sports Bar**, 740 Bragg Boulevard, Fayetteville, NC 28301; **Off-limits: 30 August 2022**; Concerns: Crime, illegal drugs, and alcohol beverage control violations.

j. **The Mansion Cabaret**, 1200 Bragg Boulevard, Fayetteville, NC 28310: **Off-limits: 30 August 2022**; Concerns: Crime, illegal drugs, gang activity, and alcohol beverage control violations.

k. **Phat Daddy's Bar and Grill**, 3406 Raeford Road, Fayetteville, NC 28303: **Off-limits: 30 August 2022**; Concerns: Crime, illegal drugs, gang activity, and alcohol beverage control violations.

2. Armed Forces personnel observed in off-limits establishments are in violation of a lawful order and are subject to apprehension and prosecution for violation of the UCMJ.

3. This memorandum supersedes Memorandum from Armed Forces Disciplinary Control Board, this headquarters, dated 11 May 2023.
